Authority of the Montana Board of Crime Control to audit Pine Hills Correctional Facility

The Juvenile Justice & Delinquency Prevention (JJDP) Act requires that states establish a system to monitor compliance with the core requirements of the JJDP Act. The Montana Manual for Monitoring Compliance with the Youth Court Act and JJDP Act describes Montana's monitoring system and provides for the establishment of monitoring standards for juveniles in the custody.

MBCC hired a contractor to serve as a Youth Custody Compliance Monitor for auditing procedures and practices to ensure that youth are held and processed in compliance with all current state and federal laws.

3. SERVICES

Contractor shall supply to the State the following services:

- Written documentation of current law enforcement departments' and secure facilities' classification, practices, and written policies and procedures for the purpose of processing and placement of juveniles by public authority within Montana;
- Written documentation of the results of on-site verification to ensure that self-reported compliance data are complete, accurate, and supported by adequate documentation in local files for:
 - 100% of the most recent twelve months of youth records in the files of adult jails and lock-ups; and
 - a random sample of at least 10% of the most recent twelve months of youth records in the files of juvenile correctional, juvenile detention, and approved co-located facilities.
- Assurance that youth are held and processed in compliance with all current state and federal laws, administrative rules/regulations, policies and procedures relevant to the holding of juveniles in juvenile correctional facilities, juvenile detention facilities, co-located facilities, adult jails, adult lock-ups, adult prisons, non-licensed co-located detention facilities, and non-secure holdover programs.
