#### **AUDIT FINDINGS**

#### **NARRATIVE**

The Montana Department of Corrections (MDOC) requested a PREA Audit for the Great Falls Youth Transition Center (YTC) located in Great Falls, Montana. The pre-audit work began on April 13, 2017 and the onsite portion of the PREA Audit was conducted between July 24, 2017 and July 26, 2017. (NOTE: For the purposes of this PREA Report the term "Agency" always represents the MDOC and the term "Facility" at all times represents Great Falls Youth Transition Center).

The Data Audit Framework used by this Auditor to assess the Agency's and Facility's compliance with the PREA Standards relied on Agency policies, Facility procedures, the Pre-Audit Questionnaire and associated attachments. Further, the Data Audit Framework relied on interviews with 15 staff [nine from the Facility and five (5) from the Agency], seven (7) residents (100.0% of all residents at the facility), a review of 11 client files (including all current residents and four files of former residents, 13 staff files, as well as interviews with local area services providers [local area rape crisis center and local hospitals that would be used for forensic exams]).

#### **DESCRIPTION OF FACILITY CHARACTERISTICS**

The Great Falls Youth Transition Center (also known as the Facility) is currently designed to house up to seven-minimum security male residents between the ages of 10 and 17 that have been committed to the MDOC (also known as the Agency). As of the onsite audit there were seven (7) juvenile offenders at the Facility. To accommodate those residents the Facility employees approximately 13 staff positions (eight (8) full-time and five (5) part-time) of which all 13 are considered "security" staff for the purpose of the staff-to-resident ratio as defined by PREA.

The Facility is in a residential neighborhood and is comprised of two main buildings, of which the MDOC has access to one [The other building is owned by the landlord and is not available for use by MDOC]. The main buildings is comprised of four "levels": (1) Level One, or the basement, contains a bedroom, bathroom, closets, and laundry area; (2) Level Two, or the main living area, is comprised of the kitchen, two large 'great rooms" containing televisions, a smaller 'great room' that is used for training and socializing, and a staff duty station; (3) Level Three, or the main housing area, contains three bedrooms and one bathroom; and (4) Level Four, or the Administrative Offices, contains the Facility Head's office, staff duty station, copier and a staff bathroom. In addition, there is one storage shed located outside the main building. Residents are not under constant supervision as residents are allowed, based on earning privileges, the opportunity to go to the corner store or to work at local businesses in the community. Further, the Facility does not have any cameras.

Routine medical care and mental health care is provided offsite. At the time of the onsite audit portion of this PREA Audithere were a total of zero (0) volunteers and contractors authorized to enter the Facility. The Facility has had one previous PREA Audit (Cycle One, Year Three [2016]).

#### **SUMMARY OF AUDIT FINDINGS**

Prior to the onsite auditing conducted between July 24, 2017, and July 26, 2017, for this PREA Audit it was confirmed, via photographic email evidence provided by the Facility PREA Compliance Manager (PCM), that the required PREA Audit notice was posted. That evidence confirmed that the notices were posted 42-days in advance and that they were posted in various, conspicuous, areas throughout the Facility.

Starting on June 26, 2017, this Auditor received an overnight package containing the completed Pre-Audit Questionnaire. Upon review of the information and data provided, it became clear that the Facility had taken significant steps toward meeting PREA compliance. A conference call with this Auditor, the Interim PREA Coordinator, and the Facility's Superintendent was conducted on July 11, 2017, and confirmed that the Facility was ready for a PREA compliance audit.

On the first day (July 24, 2017) of onsite auditing an introduction meeting was held at approximately 8:30 AM with the Facility Superintendent and the Interim State PREA Coordinator. It was noted that there were seven (7) male residents on site at the time of the audit. It was also noted that the PREA Coordinator was an interim and that the PCM for the Facility was new to the position and being trained by the previous PCM, which is also the Facility Superintendent. Following this meeting, a tour of the entire Facility was conducted and this Auditor noted the layout of the physical grounds and the various structures. Additionally, notices about this PREA Audit as well as notices regarding the rights of the residents to be free from sexual abuse and sexual harassment were observed. These notices included information on how residents could report sexual abuse and sexual harassment. During this tour, it was noted that previous "blind spots" were removed by adding a physical barrier.

During this tour, this Auditor observed residents being supervised by the Facility Staff (i.e., security staff) but that residents' who have earned privileges could exit the facility with approval. Further, it was observed that in the Facility there were staff of both genders present. It was noted in the housing unit that a ratio of 1:8 was being maintained. During the onsite audit, this Auditor formally interviewed seven of the seven residents, meaning that 100.0% of the total facility resident population was interviewed as part of the onsite audit

As part of the routine work during the <u>onsite</u> portion of this PREA Audit, this Auditor interviewed a total of 15 staff, including security, administrators, and specialized staff. Nine of the 15-interviewed staff were security staff and represented security staff from all shifts and all facility units. This auditor interviewed 100.0% of all full-time staff and 20.0% of all part-time staff. The remaining part-time staff could not be reached by the facility during the onsite audit.

After the onsite portion of this PREA Audit, it was determined that the Facility "Exceed Standard" on one PREA Standard (115.351); "Meets Standard" on 36 PREA Standards, "Did Not Meet Standard" on one PREA Standard (115.317) while three PREA Standards (115.318; 115.332; and 115.335) were deemed "Not Applicable." The facility entered a Corrective Action Plan (CAP) period on August 18, 2017 and exited the CAP period on August 29, 2017.

During the CAP period, the facility and agency were able to complete all CAP items. Thus, it was determined that the Facility "Exceed Standard" on one PREA Standard (115.351); "Meets Standard" on 37 PREA Standards, "Did Not Meet Standard" on zero (0) PREA Standards, while three PREA Standards (115.318; 115.332; and 115.335) were deemed "Not Applicable."

The following is a Standard-by-Standard summary of this Auditor's findings, including the Corrective Actions items, if any, in this PREA Audit.

EVIDENCE OF COMPLIANCE: As evidence of compliance with this Standard, the Facility submitted or provided to this Auditor the following: 1) MDOC Policy number 1.1.17; 2) the Pre-Audit Questionnaire; 3) MDOC's Organizational Chart; 4) The Facility's Organizational Chart; 5) Facility policy number 10-5 and 6) Interviews with staff. OBSERVATIONS: The Agency's 1.1.17 Policy is determined to meet standard. Further, the Agency employees an upperlevel, agency-wide, PREA coordinator with sufficient time and authority to develop, implement, and oversee agency efforts to comply with the PREA standards in all of its facilities; and the Facility designated a PREA compliance manager with sufficient time and authority to coordinate the facility's efforts to comply with the PREA standards. DETERMINATION: Based on the observations noted above it was determined that the Agency does meet this Standard. Standard 115.312 Contracting with other entities for the confinement of residents

REQUIREMENTS: 115.312: This standard has two components: (a) A public agency that contracts for the confinement of its inmates with private agencies or other entities, including other government agencies, shall include in any new contract or contract renewal the entity's obligation to adopt and comply with the PREA standards; (b) Any new contract or contract renewal shall provide for agency contract monitoring to ensure that the contractor is complying with the PREA standards.

EVIDENCE OF COMPLIANCE: As evidence of compliance with this Standard, the Facility submitted or provided to this Auditor the following: 1) the Pre-Audit Questionnaire; 2) Samples of signed contracts; and 3) Interview(s) with the Agency and Facility staff responsible for contract monitoring.

OBSERVATIONS: The Agency began contracting for confinement services of residents after the last juvenile PREA Audit. In a review of the contract, it was noted that the contract included the entity's obligation to adopt and comply with the PREA standards and that the contract did have language that ensured that contract monitoring was provided. Agency staff interviews confirmed that contactor monitoring did take place, including at least quarterly site visits to the facility.

DETERMINATION: Based on the observations noted above it was determined that the Agency *does* meet this standard.

REQUIREMENTS: 115.313: This standard has four components: (a) a staffing plan has been created; (b) deviations from the staffing plan are documented; (c) the staffing plan is reviewed annually; and (d) for secure facilities, where unannounced rounds occur, staff are prohibited from alerting other staff that such rounds are occurring.

EVIDENCE OF COMPLIANCE: As evidence of compliance with this Standard, the Facility submitted or provided to this Auditor the following: 1) MDOC Policy number 1.1.17; 2) the Pre-Audit Questionnaire; 3) Facility's Staffing Plan; 4) Review of Unannounced Rounds Log; and 5) Interviews with staff.

OBSERVATIONS: The Facility's Staffing Plan, as presented, is consistent with the intent of the PREA Standard

DETERMINATION: It was determined that the Facility *does* meet this Standard.

#### **Standard 115.315 Limits to cross-gender viewing and searches**

Auditor discussion, including the evidence relied upon in making the compliance or non-compliance determination, the auditor's analysis and reasoning, and the auditor's conclusions. This discussion must also include corrective action recommendations where the facility does not meet standard. These recommendations must be included in the Final Report, accompanied by information on specific corrective actions taken by the facility.

REQUIREMENTS: 115.315: This standard has six components: (a) The facility shall not conduct cross-gender strip searches or cross-gender visual body cavity searches (meaning a search of the anal or genital opening) except in exigent circumstances or when performed by medical practitioners; (b) The agency shall not conduct cross-gender pat-down searches except in exigent circumstances; (c) The facility shall document all cross-gender strip searches and cross-gender visual body cavity

searches, and shall document all cross-gender pat-down searches of female inmates; (d) The facility shall implement policies and procedures that enable inmates to shower, perform bodily functions, and change clothing without nonmedical staff of the opposite gender viewing their breasts, buttocks, or genitalia, except in exigent circumstances or when such viewing is incidental to routine cell checks. Such policies and procedures shall require staff of the opposite gender to announce their presence when entering an inmate housing unit; (e) The facility shall not search or physically examine a transgender or intersex inmate for the sole purpose of determining the inmate's genital status. If the inmate's genital status is unknown, it may be determined during conversations with the inmate, by reviewing medical records, or, if necessary, by learning that information as part of a broader medical examination conducted in private by a medical practitioner; and (f) The agency shall train security staff in how to conduct cross-gender pat-down searches, and searches of transgender and intersex inmates, in a professional and respectful manner, and in the least intrusive manner possible, consistent with security needs.

EVIDENCE OF COMPLIANCE: As evidence of compliance with this Standard, the Facility submitted or provided to this Auditor the following: 1) MDOC Policy number 1.1.17; 2) the Pre-Audit Questionnaire; 3) Interviews with nine security staff; 3) Review of staff training files; and 4) Interviews with residents (specifically, all seven residents enrolled at the Facility during the audit).

OBSERVATIONS: Based on observation, document review, and interviews, the Facility was compliant with all PREA components related to this Standard.

DETERMINATION: It was determined that the Facility does meet this Standard.

#### Standard 115.316 Residents with disabilities and residents who are limited English proficient

Auditor discussion, including the evidence relied upon in making the compliance or non-compliance determination, the auditor's analysis and reasoning, and the auditor's conclusions. This discussion must also include corrective action recommendations where the facility does not meet standard. These recommendations must be included in the Final Report, accompanied by information on specific corrective actions taken by the facility.

REQUIREMENTS: 115.316: This standard has three components: (a) The agency shall take appropriate steps to ensure that inmates with disabilities (including, for example, inmates who are deaf or hard of hearing, those who are blind or have low vision, or those who have intellectual, psychiatric, or speech disabilities), have an equal opportunity to participate in or benefit from all aspects of the agency's efforts to prevent, detect, and respond to sexual abuse and sexual harassment; (b) The agency shall take reasonable steps to ensure meaningful access to all aspects of the agency's efforts to prevent, detect, and respond to sexual abuse and sexual harassment to inmates who are limited English proficient, including steps to provide interpreters who can interpret effectively, accurately, and impartially, both receptively and expressively, using any necessary specialized vocabulary; and (c) The agency shall not rely on inmate interpreters, inmate readers, or other types of inmate assistants except in limited circumstances where an extended delay in obtaining an effective interpreter could compromise the inmate's safety, the performance of first-response duties under §115.64, or the investigation of the inmate's allegations.

EVIDENCE OF COMPLIANCE: As evidence of compliance with this Standard, the Facility submitted or provided to this Auditor the following: 1) the MDOC Policy number 1.1.17; 2) the Pre-Audit Questionnaire; 3) Various forms; 4) Interviews with nine security staff; 5) the contract for Interpreter Services through an outside provider; and 6) Interviews with residents.

OBSERVATIONS: MDOC Policy 1.1.17 complies with this standard. Further, the Agency maintains a contract for Interpreter Services with an outside service that is utilized as needed. In interviews with security staff all nine reported that they would either access the translation services or secure approval from supervisor to do so. Further, all of the staff reported that they would NOT allow residents to interpret for other residents unless it was an exigent circumstance.

DETERMINATION: It was determined that the Facility does meet this Standard.

REQUIREMENTS: 115.317: This standard has eight components: (a) The agency shall not hire or promote anyone who may have contact with inmates, and shall not enlist the services of any contractor who may have contact with inmates, who— [(1) Has engaged in sexual abuse in a prison, jail, lockup, community confinement facility, juvenile facility, or other institution (as defined in 42 U.S.C. 1997); (2) Has been convicted of engaging or attempting to engage in sexual activity in the community facilitated by force, overt or implied threats of force, or coercion, or if the victim did not consent or was unable to consent or refuse; or (3) Has been civilly or administratively adjudicated to have engaged in the activity described in paragraph (a)(2) of this section]; (b) The agency shall consider any incidents of sexual harassment in determining whether to hire or promote anyone, or to enlist the services of any contractor, who may have contact with inmates; (c) Before hiring new employees who may have contact with inmates, the agency shall: [(1) Perform a criminal background records check; and (2) Consistent with Federal, State, and local law, make its best efforts to contact all prior institutional employers for information on substantiated allegations of sexual abuse or any resignation during a pending investigation of an allegation of sexual abuse]; (d) The agency shall also perform a criminal background records check before enlisting the services of any contractor who may have contact with inmates; (e) The agency shall either conduct criminal background records checks at least every five years of current employees and contractors who may have contact with inmates or have in place a system for otherwise capturing such information for current employees; (f) The agency shall ask all applicants and employees who may have contact with inmates directly about previous misconduct described in paragraph (a) of this section in written applications or interviews for hiring or promotions and in any interviews or written self-evaluations conducted as part of reviews of current employees. The agency shall also impose upon employees a continuing affirmative duty to disclose any such misconduct; (g) Material omissions regarding such misconduct, or the provision of materially false information, shall be grounds for termination; and (h) Unless prohibited by law, the agency shall provide information on substantiated allegations of sexual abuse or sexual harassment involving a former employee upon receiving a request from an institutional employer for whom such employee has applied to work.

EVIDENCE OF COMPLIANCE: As evidence of compliance with this Standard, the Facility relied on the following: 1) Pre-Audit Questionnaire; 2) MDOC Policy 1.1.17; 3) Review of 13 staff files; 4) Review of contractor and volunteer files; and 5) Onsite audit interviews with staff (specifically, MDOC Human Resource staff).

OBSERVATIONS: In a review of 13 staff files and interviews with HR staff, found that background checks were performed on all new hires and for staff employed for more than four years. Child abuse registries were checked prior to staff being employed. Further, former institutional employers were contacted. The agency does ask all staff who may have contact with residents about if they have "been civilly or administratively adjudicated to have engaged in the activity described in paragraph (a)(2) of this section" and these questions are being asked during the promotion process and during annual performance evaluation. Further, the Agency is considering any incidents of sexual harassment in determining whether to hire an employee but only asks about sexual harassment instances related to inmates and residents during promotions. However, this is determined to meet the intent of the standard. This auditor could not find any policy or procedure that imposes upon employees a continuing affirmative duty to disclose any such misconduct (specifically civil). Interviews with HR Staff noted

that the Agency would provide, to the extent allowable by law, information related to a substantiated allegation of sexual abuse or sexual harassment to other law enforcement agencies.

DETERMINATION: It was determined that the agency does not meet this Standard.

CORRECTIVE ACTION PLAN (CAP): The facility entered the CAP period on August 18, 2017. The agency/facility shall: (1) Revise policy to ensure that staff have a continuing affirmative duty to disclose any such misconduct described in this Standard and (2) Submit to this Auditor evidence that the revised policy/procedure is in effect.

FINAL DETERMINATION: During the CAP period, the agency and facility were able to revise policy to ensure that staff have a continuing affirmative duty to disclose any such misconduct described in this Standard and agency staff submit to this Auditor evidence that the revised policy/procedure is in effect. Thus, on August 29, 2017, the agency and facility were deemed to meet this standard.

#### Standard 115.318 Upgrades to facilities and technologies

These recommendations must be included in the Final Report, accompanied by information on specific corrective actions taken by the facility.

REQUIREMENTS: 115.318: This standard has two components: (a) When designing or acquiring any new facility and in planning any substantial expansion or modification of existing facilities, the agency shall consider the effect of the design, acquisition, expansion, or modification upon the agency's ability to protect residents from sexual abuse; and (b) When installing or updating a video monitoring system, electronic surveillance system, or other monitoring technology, the agency shall consider how such technology may enhance the agency's ability to protect residents from sexual abuse.

EVIDENCE OF COMPLIANCE: As evidence of compliance with this Standard, the Facility submitted or provided to this Auditor the Pre-Audit Questionnaire, a facility tour, and interviews with staff (specifically, the Facility Superintendent and the Facility's staff and residents).

OBSERVATIONS: There have been no substantial expansion or modifications to any Facilities since August 2012.

DETERMINATION: Based on the Agency and Facility policies and procedures, Pre-Audit Questionnaire, and the Onsite Audit (including the Facility tour and the staff and resident interviews), it was determined that this Standard is *not applicable* to the Facility.

#### Standard 115.321 Evidence protocol and forensic medical examinations

REQUIREMENTS: 115.321: This standard has eight components: (a) To the extent the agency is responsible for investigating allegations of sexual abuse, the agency shall follow a uniform evidence protocol that maximizes the potential for obtaining usable physical evidence for administrative proceedings and criminal prosecutions; (b) The protocol shall be developmentally appropriate for youth and, as appropriate, shall be adapted from or otherwise based on the most recent edition of the U.S. Department of Justice's Office on Violence Against Women publication, "A National Protocol for Sexual Assault Medical Forensic Examinations, Adults/Adolescents," or similarly comprehensive and authoritative protocols developed after 2011; (c) The agency shall offer all residents who experience sexual abuse access to forensic medical examinations whether on-site or at an outside facility, without financial cost, where evidentiary or medically appropriate. Such examinations shall be performed by Sexual Assault Forensic Examiners (SAFEs) or Sexual Assault Nurse Examiners (SANEs) where possible. If SAFEs or SANEs cannot be made available, the examination can be performed by other qualified medical practitioners. The agency shall document its efforts to provide SAFEs or SANEs; (d) The agency shall attempt to make available to the victim a victim advocate from a rape crisis center. If a rape crisis center is not available to provide victim advocate services, the agency shall make available to provide these services a qualified staff member from a community-based organization or a qualified agency staff member. Agencies shall document efforts to secure services from rape crisis centers. For the purpose of this standard, a rape crisis center refers to an entity that provides intervention and related assistance, such as the services specified in 42 U.S.C. 14043g(b)(2)(C), to victims of sexual assault of all ages. The agency may utilize a rape crisis center that is part of a governmental unit as long as the center is not part of the criminal justice system (such as a law enforcement agency) and offers a comparable level of confidentiality as a nongovernmental entity that provides similar victim services; (e) As requested by the victim, the victim advocate, qualified agency staff member, or qualified community-based organization staff member shall accompany and support the victim through the forensic medical examination process and investigatory interviews and shall provide emotional support, crisis intervention, information, and referrals; (f) To the extent the agency itself is not responsible for investigating allegations of sexual abuse, the agency shall request that the investigating agency follow the requirements of paragraphs (a) through (e) of this section; (g) The requirements of paragraphs (a) through (f) of this section shall also apply to: [(1) Any State entity outside of the agency that is responsible for investigating allegations of sexual abuse in juvenile facilities; and (2) Any Department of Justice component that is responsible for investigating allegations of sexual abuse in juvenile facilities.] (h) For the purposes of this standard, a qualified agency staff member or a qualified communitybased staff member shall be an individual who has been screened for appropriateness to serve in this role and has received education concerning sexual assault and forensic examination issues in general.

EVIDENCE OF COMPLIANCE: As evidence of compliance with this Standard, the Facility submitted or provided to this Auditor the (1) Pre-Audit Questionnaire, (2) MDOC Policy 1.1.17, (3) Interviews with the PREA Compliance Manager (PCM), and (4) interviews with staff (specifically, the Facility Superintendent, Agency investigator, and Facility investigator).

OBSERVATIONS: The Facility does have investigators who conduct both criminal and administrative investigations. There is documentation that local law enforcement and/or local hospitals whose staff may perform a forensic exam were asked to utilize the most recent edition of the U.S. Department of Justice's Office on Violence Against Women publication, "A National Protocol for Sexual Assault Medical Forensic Examinations, Adults/Adolescents," or similarly comprehensive and authoritative protocols developed after 2011.

DETERMINATION: It was determined that the Facility *does* meet this Standard.

REQUIREMENTS: 115.322: This standard has five components: (a) The agency shall ensure that an administrative or criminal investigation is completed for all allegations of sexual abuse and sexual harassment; (b) The agency shall have in place a policy to ensure that allegations of sexual abuse or sexual harassment are referred for investigation to an agency with the legal authority to conduct criminal investigations, unless the allegation does not involve potentially criminal behavior. The agency shall publish such policy on its website or, if it does not have one, make the policy available through other means. The agency shall document all such referrals; (c) If a separate entity is responsible for conducting criminal investigations, such publication shall describe the responsibilities of both the agency and the investigating entity; (d) Any State entity responsible for conducting administrative or criminal investigations of sexual abuse or sexual harassment in juvenile facilities shall have in place a policy governing the conduct of such investigations of sexual abuse or sexual harassment in juvenile facilities shall have in place a policy governing the conduct of such investigations.

EVIDENCE OF COMPLIANCE: As evidence of compliance with this Standard, the Facility submitted or provided to this Auditor the (1) Pre-Audit Questionnaire, (2) MDOC Policy 1.1.17, (3) MDOC Policy 3.3.3., (4) interviews with staff (specifically, the Facility Superintendent, the Agency investigator, and the Facility investigator), (5) Copies of completed investigations, and (6) the Facility website.

OBSERVATIONS: The Facility does have a policy that all allegations of sexual abuse and sexual harassment would be investigated. This policy (with effective date 6/28/2016) adequately addresses the components related to this PREA standard. In addition, interviews of staff and residents confirmed that any allegations of sexual abuse or sexual harassment would be investigated.

DETERMINATION: It was determined that the Facility does meet this Standard.

#### **Standard 115.331 Employee training**

The employee shall receive additional training if the employee is reassigned from a facility that houses only male residents to a facility that houses only female residents, or vice versa; (c) All current employees who have not received such training shall be trained within one year of the effective date of the PREA standards, and the agency shall provide each employee with refresher training every two years to ensure that all employees know the agency's current sexual abuse and sexual harassment policies and procedures. In years in

EVIDENCE OF COMPLIANCE: As evidence of compliance with this Standard, the Facility submitted or provided to this Auditor the (1) Pre-Audit Questionnaire, (2) MDOC Policy 1.1.17, (3) interviews with staff, (4) Training forms, and (5) Training curricula.

OBSERVATIONS: All nine of the security staff interviewed noted that they did receive all of the required PREA training. All staff interviews noted they felt they receive training that was specific to the "unique needs and attributes and gender of the residents at the Facility." In a review of staff files it was apparent that staff received the required PREA training prior to having contact with residents.

DETERMINATION: It was determined that the Facility *does* meet this Standard.

#### Standard 115.332 Volunteer and contractor training

REQUIREMENTS: 115.332: This standard has three components: (a) The agency shall ensure that all volunteers and contractors who have contact with residents have been trained on their responsibilities under the agency's sexual abuse and sexual harassment prevention, detection, and response policies and procedures; (b) The level and type of training provided to volunteers and contractors shall be based on the services they provide and level of contact they have with residents, but all volunteers and contractors who have contact with residents shall be notified of the agency's zero-tolerance policy regarding sexual abuse and sexual harassment and informed how to report such incidents; and (c) The agency shall maintain documentation confirming that volunteers and contractors understand the training they have received.

EVIDENCE OF COMPLIANCE: The Facility's Pre-Audit Questionnaire, training forms, training curricula, and interviews with staff.

OBSERVATIONS: The facility did not have any volunteers or contractors.

DETERMINATION: It was determined that this standard is not applicable.

REQUIREMENTS: 115.333: This standard has six components: (a) During the intake process, residents shall receive information explaining, in an age appropriate fashion, the agency's zero tolerance policy regarding sexual abuse and sexual harassment and how to report incidents or suspicions of sexual abuse or sexual harassment; (b) Within 10 days of intake, the agency shall provide comprehensive age-appropriate education to residents either in person or through video regarding their rights to be free from sexual abuse and sexual harassment and to be free from retaliation for reporting such incidents, and regarding agency policies and procedures for responding to such incidents; (c) Current residents who have not received such education shall be educated within one year of the effective date of the PREA standards, and shall receive education upon transfer to a different facility to the extent that the policies and procedures of the resident's new facility differ from those of the previous facility; (d) The agency shall provide resident education in formats accessible to all residents, including those who are limited English proficient, deaf, visually impaired, or otherwise disabled, as well as to residents who have limited reading skills; (e) The agency shall maintain documentation of resident participation in these education sessions; and (f) In addition to providing such education, the agency shall ensure that key information is continuously and readily available or visible to residents through posters, resident handbooks, or other written formats.

EVIDENCE OF COMPLIANCE: As evidence of compliance with this Standard, the Facility submitted or provided to this Auditor the (1) Pre-Audit Questionnaire, (2) MDOC Policy 1.1.17, (3) interviews with residents, (4) Training forms, (5) Training curricula, and (6) A review of 11 resident files (both current and former residents).

OBSERVATIONS: In a review of seven current residents' files (100.0% of current resident population) and four (4) former resident files it was found that all residents, or 100.0%, had documentation noting when the residents PREA information was provided and all 11, or 100.0%, did have documentation supporting the fact that they received PREA Education within 10 days of Intake.

DETERMINATION: It was determined that the Facility *does* meet this Standard.

EVIDENCE OF COMPLIANCE: As evidence of compliance with this Standard, the Facility submitted or provided to this Auditor the (1) Pre-Audit Questionnaire, (2) MDOC Policy 1.1.17, (3) interviews with Agency and Facility investigators, and (4) Training forms.

OBSERVATIONS: Agency provided evidence that all investigators had completed the required PREA training. The Facility did provide evidence that all the designated Facility Investigator's completed this training. Interviews with investigators noted that each had received the required training.

DETERMINATION: It was determined that the Facility does meet this Standard.

#### Standard 115.335 Specialized training: Medical and mental health care

REQUIREMENTS: 115.335: This standard has four components: (a) The agency shall ensure that all full- and part-time medical and mental health care practitioners who work regularly in its facilities have been trained in [(1) How to detect and assess signs of sexual abuse and sexual harassment; (2) How to preserve physical evidence of sexual abuse; (3) How to respond effectively and professionally to juvenile victims of sexual abuse and sexual harassment; and (4) How and to whom to report allegations or suspicions of sexual abuse and sexual harassment]; (b) If medical staff employed by the agency conduct forensic examinations, such medical staff shall receive the appropriate training to conduct such examinations; (c) The agency shall maintain documentation that medical and mental health practitioners have received the training referenced in this standard either from the agency or elsewhere; and (d) Medical and mental health care practitioners shall also receive the training mandated for employees under §115.331 or for contractors and volunteers under §115.332, depending upon the practitioner's status at the agency.

EVIDENCE OF COMPLIANCE: As evidence of compliance with this Standard, the Facility submitted or provided to this Auditor the (1) Pre-Audit Questionnaire, (2) MDOC Policy 1.1.17, (3) interviews with staff, and (4) Training forms.

OBSERVATIONS: Interviews with the administrative staff confirmed that there are no full-time nor part-time medical and mental health care practitioners who work regularly in the Facility.

DETERMINATION: Based on the Agency and Facility policies and procedures, Pre-Audit Questionnaire, and the Onsite Audit (including the Facility tour and the staff and resident interviews), it was determined that this Standard is *not applicable* to the Facility.

REQUIREMENTS: 115.341: This standard has five components: (a) Within 72 hours of the resident's arrival at the facility and periodically throughout a resident's confinement, the agency shall obtain and use information about each resident's personal history and behavior to reduce the risk of sexual abuse by or upon a resident; (b) Such assessments shall be conducted using an objective screening instrument; (c) At a minimum, the agency shall attempt to ascertain 11 pieces of required information (see standard); (d) This information shall be ascertained through conversations with the resident during the intake process and medical and mental health screenings; during classification assessments; and by reviewing court records, case files, facility behavioral records, and other relevant documentation from the resident's files; and (e) The agency shall implement appropriate controls on the dissemination within the facility of responses to questions asked pursuant to this standard in order to ensure that sensitive information is not exploited to the resident's detriment by staff or other residents.

OBSERVATIONS: The Facility uses a risk assessment tool that utilizes each resident's intake responses to a variety of questions, including past victimizations and abusiveness. This information is used to help determine a youth's risk of sexual aggression and sexual vulnerability. The staff uses a screening tool, a personal interview, and any other available relevant records to assess each youth's risk for sexual aggressive behavior and vulnerability to sexual victimization. Staff are aware that they are to consider gender nonconforming or manner or identification. In a review of 11 resident files, all 11, or 100.0%, did have documentation showing that a Screening was performed within the required 72-hour timeframe.

DETERMINATION: It was determined that the Facility does meet this Standard.

#### **Standard 115.342 Use of screening information**

REQUIREMENTS: 115.342: This standard has nine components: (a) The agency shall use all information obtained pursuant to § 115.341 and subsequently to make housing, bed, program, education, and work assignments for residents with the goal of keeping all residents safe and free from sexual abuse; (b) Residents may be isolated from others only as a last resort when less restrictive measures are inadequate to keep them and other residents safe, and then only until an alternative means of keeping all residents safe can be arranged. During any period of isolation, agencies shall not deny residents daily large-muscle exercise and any legally required educational programming or special education services. Residents in isolation shall receive daily visits from a medical or mental health care clinician. Residents shall also have access to other programs and work opportunities to the extent possible; (c) Lesbian, gay, bisexual, transgender, or intersex residents shall not be placed in PREA Audit Report

OBSERVATIONS: All nine staff interviewed supported the contention that the Facility "never" places a resident in isolation for their own protection against sexual victimization. In a review of the policy (1.1.17) it was stated that the Facility could place a resident in isolation for their own protection. Though the facility staff did not know if a transgender or intersex resident had been in the facility, each staff interviewed recognized that there were no areas of the facility designated as housing areas for these residents.

DETERMINATION: It was determined that the Facility does meet this Standard.

REQUIREMENTS: 115.351: This standard has five components: (a) The agency shall provide multiple internal ways for residents to privately report sexual abuse and sexual harassment, retaliation by other residents or staff for reporting sexual abuse and sexual harassment, and staff neglect or violation of responsibilities that may have contributed to such incidents; (b) The agency shall also provide at least one way for residents to report abuse or harassment to a public or private entity or office that is not part of the agency and that is able to receive and immediately forward resident reports of sexual abuse and sexual harassment to agency officials, allowing the resident to remain anonymous upon request. Residents detained solely for civil immigration purposes shall be provided information on how to contact relevant consular officials and relevant officials at the Department of Homeland Security; (c) Staff shall accept reports made verbally, in writing, anonymously, and from third parties and shall promptly document any verbal reports; (d) The facility shall provide residents with access to tools necessary to make a written report; and (e) The agency shall provide a method for staff to privately report sexual abuse and sexual harassment of residents.

EVIDENCE OF COMPLIANCE: As evidence of compliance with this Standard, the Facility submitted or provided to this Auditor the (1) Pre-Audit Questionnaire, (2) MDOC Policy 1.1.17, (3) interviews with residents, (4) Interviews with staff, (5)

Access to the phone system to make a call to an outside agency; and (6) Review of allegations and investigations of those allegations.

OBSERVATIONS: All staff and residents were able to identify multiple internal ways for a youth to report privately to Facility officials about sexual abuse, sexual harassment, retaliation, and staff neglect or violation of responsibilities that may have contributed to any such incidents. All of the interviewed residents noted that they would tell a staff member, use the posted phone numbers and/or report to their parent or guardians. Posters with the hotline numbers were observed posted in each residential unit at Facility. A test of the PREA Hotline noted that the call was answered immediately and by a "live" person. Further, it was found that a "live" person answered the phone 24/7 and that the PREA Coordinator is immediately notified. Further, it was determined that the resident calling this number could remain anonymous if they so choose. As for residents detained solely for civil immigration purposes, this practice is not allowed per statement from the Facility and interviews with staff. All staff, who were interviewed, acknowledged that they must report all verbal reports, anonymous reports, written reports, and reports from third parties regarding allegations of sexual abuse and sexual harassment."

DETERMINATION: It was determined that the Facility exceeds the requirements for this Standard.

REQUIREMENTS: 115.352: This standard has seven components: (a) An agency shall be exempt from this standard if it does not have administrative procedures to address resident grievances regarding sexual abuse; (b)(1) The agency shall not impose a time limit on when a resident may submit a grievance regarding an allegation of sexual abuse; (2) The agency may apply otherwise-applicable time limits on any portion of a grievance that does not allege an incident of sexual abuse; (b)(3) The agency shall not require a resident to use any informal grievance process, or to otherwise attempt to resolve with staff, an alleged incident of sexual abuse; (b)(4) Nothing in this section shall restrict the agency's ability to defend against a lawsuit filed by a resident on the ground that the applicable statute of limitations has expired; (c) The agency shall ensure that [(1) A resident who alleges sexual abuse may submit a grievance without submitting it to a staff member who is the subject of the complaint, and (2) Such grievance is not referred to a staff member who is the subject of the complaintl; (d)(1) The agency shall issue a final agency decision on the merits of any portion of a grievance alleging sexual abuse within 90 days of the initial filing of the grievance; (d)(2) Computation of the 90-day time period shall not include time consumed by residents in preparing any administrative appeal; (d)(3) The agency may claim an extension of time to respond, of up to 70 days, if the normal time period for response is insufficient to make an appropriate decision. The initial response and final agency decision shall document the agency's determination whether the resident is in substantial risk of imminent sexual abuse and the action taken in response to the emergency grievance; and (g) The agency may discipline a resident for filing a grievance related to alleged sexual abuse only where the agency demonstrates that the resident filed the grievance in bad faith.

EVIDENCE OF COMPLIANCE: As evidence of compliance with this Standard, the Facility submitted or provided to this Auditor the (1) Pre-Audit Questionnaire, (2) MDOC Policy 3.3.3., and (3) Interviews with staff.

OBSERVATIONS: The agency's Offender Grievance Program (with effective date 6/28/2016) meets the components related to this standard. Further, staff interviews acknowledged that the Offender Grievance Program would be followed.

DETERMINATION: It was determined that the Facility does meet this Standard.

OBSERVATIONS: The Facility provided contact phone numbers and addresses to the Montana Department of Corrections and with Voices of Hope in Great Falls. All interviews (staff and residents) confirmed and acknowledged that residents are provided with reasonable access to parents or legal guardians and that all residents are provided reasonable and confidential

access to their attorneys or other legal representative.

DETERMINATION: It was determined that the Facility does meet this Standard.

OBSERVATIONS: This Facility has multiple means of receiving third-party reports, including phone calls to the Facility and via the dial 9 number. Further, the Facility's website has a process for families to report sexual abuse and sexual harassment.

DETERMINATION: It was determined that the Facility does meet this Standard.

DETERMINATION: It was determined that the Facility does meet this Standard.

Further, all interviewed residents noted that they would "tell staff" if they felt they were at a substantial risk of imminent sexual abuse.

DETERMINATION: It was determined that the Facility, in all material ways, meets this Standard.

For allegations involving a resident of a juvenile facility the administrator will also notify the appropriate investigative agency." Interviews with the Facility Head noted he understood this requirement.

EVIDENCE OF COMPLIANCE: As evidence of compliance with this Standard, the Facility submitted or provided to this Auditor the (1) Pre-Audit Questionnaire, (2) MDOC Policy 1.1.17, (3) YTC 10-5, (4) Interviews with staff, and (5) Interviews with the Facility Head.

OBSERVATIONS: All staff reported that they understood their role as first responder and all nine staff who were interviewed were able to describe the procedures that a first responder is to use. YTC Policy 10-5 adheres to this Standard.

DETERMINATION: It was determined that the Facility does meet this Standard.

OBSERVATIONS: The Facility could provide a written *Coordinated Response Plan* and all staff interviewed noted that they would follow the CRP, if a sexual abuse allegation was alleged.

OBSERVATIONS: An interview with the MDOC Agency Head designee noted that the agency/state *does* have a collective bargaining agreement that was completed since August of 2016, and being renegotiated this month. However, nothing in the agreement limits the agency's ability to remove alleged staff sexual abusers from contact with residents pending the outcome of an investigation or of a determination of whether and to what extent discipline is warranted.

DETERMINATION: It was determined that the Facility, in all material ways, meets this Standard.

OBSERVATIONS: Policy 1.1.17 addresses this Standard and in interviews with staff confirmed they would document these attempts.

Interviews with administrative staff noted that they would prohibit further contact with residents, in the case of any violation of agency sexual abuse or sexual harassment policies by a service provider or volunteer and the staff interviewed noted that HR would make contact with the appropriate licensing bodies.

OBSERVATIONS: It was noted that MDOC Policy 1.1.17 that youth will be disciplined per the appropriate disciplinary code or PREA Audit Report 28

code of conduct. OBSERVATIONS: Staff interviews acknowledge that staff are aware that medical or mental health practitioner must be offered to a youth within 14 days of staff learning that the youth has experienced prior sexual victimization or has perpetrated sexual abuse. Further, in a review of resident files, of residents who reported prior sexual victimization or sexual abuse perpetration, found that one had documentation that they were offered a medical or mental health follow-up.

DETERMINATION: It was determined that the Facility does meet this Standard.

Nine of nine interviews (100.0%) with staff, who are all trained as first responders, confirmed this component and noted that they are trained to protect the victim and to notify a supervisor who will notify the appropriate medical and mental health practitioners. Further, interviews acknowledged that resident victims of sexual abuse while incarcerated shall be offered timely information about and timely access to emergency contraception and sexually transmitted infections prophylaxis, in accordance with professionally accepted standards of care, where medically appropriate
