

**CONTRACT AMENDMENT NO. 7**

This CONTRACT AMENDMENT No. 7 amends the above-referenced Contract between the **State of Montana, Department of Corrections** (State), whose address and phone number are P.O. Box 201301, 5 South Last Chance Gulch, Helena, MT 59620-1301, 406-444-3930 and Compliance Monitoring Systems, LLC, whose address and phone number are 2809 Great Northern Loop, Suite 200, Missoula, MT 59808, (406) 529-1789.

This Contract is amended for the following purpose(s) (new language underlined, deleted language interlined):

- 1) In accordance with Section 1, of the above-referenced Contract, entitled Effective Date, Duration, and Renewal, parties mutually agree to extend this Contract for the period ~~January 1, 2022~~, July 1, 2023, through ~~June 30, 2023~~, June 30, 2025, per the terms, conditions, and prices agreed upon This is the ~~2<sup>nd</sup>~~ 6<sup>th</sup> renewal, 5<sup>th</sup> and 6<sup>th</sup> year of the Contract. This Contract, including any renewals, may not exceed a total of seven (7) years.
- 2) In accordance with Section 5, of the above-referenced Contract, entitled Consideration/Payment, parties mutually agree to the following changes in subsection 5. In the event any subsections are removed, subsequent subsections will not be renumbered.

**5. CONSIDERATION/PAYMENT**

**5.2 Total Contract Maximum and Location Allowances.** For State fiscal year 2024 (July 1, 2023, through June 30, 2024), the contract maximum value is ~~\$1,114,878.69 (one million one hundred fourteen thousand eight hundred seventy-eight and 69/100 dollars)~~ \$889,878.69 (eight hundred eighty-nine thousand eight hundred seventy-eight and 69/100 dollars) and for state fiscal year 2025, the contract maximum value is ~~& \$1,159,473.84 (one million one hundred fifty-nine thousand four hundred seventy-three and 84/100 dollars)~~ \$934,473.84 (nine hundred thirty-four thousand four hundred seventy-three and 84/100 dollars).
