




Pine Hills Historical Facility Usage

Sight Sound Audits


- Pine Hills is audited by the Montana Board of Crime Control annually. The audit reviews sight and sound separation and Pine Hills has passed this audit every year.
- Pine Hills was audited by a PREA auditor in 2016 and 2018 and was found to be in compliance with sight sound separation during both audits.
- Pine Hills was visited and audited by a compliance analyst with the national Office of Juvenile Justice and Delinquency Prevention in August 2017. Her report stated she found “no sight and sound separation issues on site.”

2019 Legislative Audit Recommendations

“Recommendation #1 We recommend the Montana Legislature, in coordination with the Department of Corrections, resolve the compliance issues resulting from: A. Placing youth offenders in a facility used to execute sentences of adults convicted of crimes, and B. Using state youth correctional facilities contrary to the purposes outlined in state law.”

LC1058 carried by Representative Patelis is a bill being offered for the legislatures consideration to fix this.




Executive Planning Request

Pine Hills has partnered with MCE on a small farm youth job training program. The farm needs a tractor, gated irrigation pipe, swather and planting equipment. Program would train youth on planting irrigating and harvesting crops, and the caring of cattle. Including calving, tagging, giving shots branding rotational grazing and selling of livestock.


Continuous Improvement

- Pine Hills joined Performance based Standards in 2013.
- **A Data-driven Improvement Model**
- PbS data-driven improvement model identifies, monitors and improves conditions of confinement and treatment services using national standards.
- Agencies, facilities and programs in more than 30 states volunteer to participate and commit to treating all youths in custody as one of our own, by using the data to create improvement and reforms.




PbS Data

Goals

- **PINE HILLS FY 2020 AND 2021**
- Utilizing Pine Hills in the most cost-effective manner, provide services to both youth and adults as appropriate.
- Ensure services for youth and adults are provided in well maintained, safe settings, offering an environment conducive to their healthy physical and mental development, and that ensures a safe and efficient work environment for staff.
- Facilitate validated risk and needs assessments to drive individualized evidence-based programming and supervision, resulting in low recidivism rates.
- Provide opportunities for youth and adults to address court ordered restitution, community service and victim restitution.
- Place a strong emphasis on successful completion of High School or obtaining a HiSet certificate (with educational opportunities that will include enhanced vocational technical courses) while in Pine Hills.

2019 Legislative changes

2019 --HB 111 Transferred Youth Parole from Department of Corrections to Youth Court.
